### **IMPACT OF COVID-19 RESTRICTIONS ON THE COMPANY'S ANNUAL GENERAL MEETING**

Kingwest Resources Limited (ASX: KWR) (**Kingwest** or the **Company**) will be holding its Annual General Meeting at 11.00am (WST) on Monday 29 November 2021 at Level 11, 216 St Georges Terrace, Perth WA 6000 (the **Meeting**).

The Company is continuing to monitor the impact of the COVID-19 virus in Western Australia and following guidance from the Federal and State Governments. Having considered the current circumstances, at this stage the Directors have made the decision that a physical meeting will be held.
